Commissioner Faber moved to approve the Contract between Wyoming Department of Health, Behavioral Health Division and Campbell County Children's Developmental Services to provide early intervention to children ages birth through two years and their families utilizing funds provided by the Individuals with Disabilities Education Act (IDEA) and the American Rescue Plan Act, in the amount of \$55,900.53, as presented. Commissioner Faber moved to proceed with the alteration and partial vacation of T7 Road as outlined in the Viewers Report, and set March 4, 2022, at Noon, as the deadline for persons to file with the Office of Commissioners any objections to the vacation or claims for damages resulting from the alteration and vacation, pursuant to W.S. 24-3-111. Commissioner Hamm seconded the motion. All Voted – Aye. Carried.

Commissioner Faber moved to approve the District Support Grant for Means, Carter North Hannum Improvement and Service District for mag chloride application to gravel roads for dust control, in the amount of \$3,268.85 from Optional One Percent Sales Tax Fund, as presented. Commissioner Maul seconded the motion. All Voted – Aye. Carried.

Commissioner Hamm moved to approve the District Support Grant for Overbrook Improvement and Service District for district enlargement in the amount of \$4,500 from Optional One Percent Sales Tax Fund, as presented. Commissioner Maul seconded the motion. All Voted – Aye. Carried.


