Bob Tranas reviewed the Part B Contract providing services to children with disabilities three through five years of age from July 1, 2022 through June 30, 2023. Wendy Balo made a motion to receive the Part C contract for \$1,821,661.44. Tyler Watts seconded. With a unanimous vote, the motion carried.


NEXT MEETING DATE:
